Successful Session for Kids!



- **733 Bills & Resolutions Introduced**
 - 360 in the Senate
 - 373 in the House
 - 444 sent to Governor
 - 2 already vetoed
- **\$1.2B in budget cuts—but programs for kids largely saw *increases***

Advocacy Mattered in the 2025 Session



- More students will receive the support they need to **succeed in school**
- More children will enter **Kindergarten ready** to learn
- More children will have access to **health coverage** and care
- Families in deep poverty will get more **resources to meet basic needs**



Funding Equity for Public Charter Schools



- **Full Mill Levy Equalization for state-authorized public charters**
- **Phasing out At-Risk Supplemental aid**
- **Increasing the cap on the Moral Obligation Program**



Sustaining Healthy School Meals for All



- **HB25-1274:** Refers two measures to the 2025 ballot to fully fund the Healthy School Meals For All program
- **SB25-214:** Restructures the Healthy School Meals for All program if the ballot measures fail



- **SB25-004**: Child Care Waitlist Fees
- Protecting child care subsidies through the **Colorado Child Care Assistance Program (CCCAP)**



Protect Services & Ensure Accountability



- **Early Intervention:** Advocate for long-term funding fix that mitigates any negative impacts on children and families.
 - *Short-term funding fix approved*
- **Leverage Third-Party Evaluations & Rule Re-Writes:** Guide meaningful reviews of CDEC, UPK, and CCCAP.
 - Children's Campaign named to steering committee for CDEC review and CCCAP rule re-write.






