





Between 2019 and 2023, Colorado's child population decreased by roughly 28,000 kids.

However, 15 counties had an increase in child populations. Weld County had the largest increase in the number of children: Its child population grew by more than 6,000 kids. Boulder County had the biggest decline: It had roughly 6,000 fewer children in 2023 than in 2019.¹





While the birth rate in Colorado fell over the last decade, the number of babies born only decreased slightly.

The birth rate in 2023 was 50.7 births per 1,000 women ages 15 to 44, down from 61.6 births per 1,000 women a decade earlier.² The number of babies born only decreased by about 3,500 per year during that same time.

Birth rates varied by race and ethnicity. The two populations with the highest birth rates were Native Hawaiian/Other Pacific Islanders (117.3 births per 1,000 women) and Hispanic, All Races (63.6 births per 1,000 women). The population with the lowest birth rate was American Indian/Alaska Native (33.7 births per 1,000 women).³

BIRTHS IN COLORADO 2013 TO 2023




HOUSEHOLD COMPOSITION & INCOME

Seventy percent of Colorado children were living with both parents between 2019 and 2023. However, there was wide variation across counties. Grand County had the highest share of children in two-parent households (94%), while Huerfano County had the lowest share (49%).⁴

Between 6% and 7% of children — roughly 80,000 Colorado kids — lived with a grandparent as the head of their household in 2023.⁵

Between 2022 and 2023, there was no significant change in Colorado's childhood poverty rate. About 10.9% of Colorado's children were living in families with incomes at or below the federal poverty level (\$30,000 for a family of four in 2023).⁶ [See page 12 for more information on childhood poverty and household resources.]

Economic Security



Colorado has one of the lowest rates of childhood poverty in the nation and a relatively high median family income. But a closer look at the data shows there are many families who are struggling to make ends meet.

Highlights

Nearly 30% of Colorado households with children experienced financial hardship. This was even more common in single-parent homes. In 2023, 28% of households with children made less than the estimated cost of living. Sixty-nine percent of single mothers did not have enough resources to meet their basic needs, compared with 16% of households with two parents.

Colorado had significant income differences across race. In 2023, the median income among households with children was \$118,733. But there were significant gaps in income across communities: The median income among American Indian/Alaskan families was \$56,700 and the median income among Black families was \$64,200 — less than half the median income of White and Asian and Pacific Islander families.

Many more children are homeless now than in prior years. The number of children experiencing homelessness increased drastically between 2023 and 2024. According to the U.S. Department of Housing and Urban Development's January Point-in-Time count, the number of children experiencing homelessness more than doubled. The number of public school students identified as homeless also increased by roughly 28%, or 5,000 students.

FAMILY INCOME

Financial stability is vital for supporting children's growth, development, and security. Family income and changes over time help us to understand how many Colorado families have what they need — and how many do not — to afford basic needs like housing, food, and child care.



The Data


The U.S. Census Bureau's American Community Survey estimates the median income among families with children in Colorado. The Bureau also reports estimated household income in relation to the federal poverty level (FPL).

MEDIAN FAMILY INCOME

Median family income describes the middle-most income in Colorado, meaning half of Colorado families make more money and half of Colorado families make less money than the median income.

Incomes varied by family race and ethnicity.



In 2023, the median family income in Colorado

was \$118,733, well above the national median family income of \$95,700. Colorado families' incomes have been increasing each year: Between 2022 and 2023, after adjusting for inflation the median family income grew by roughly \$4,000, or 4%.¹

There were large differences in income across race, with nearly a \$100,000 difference between the highest and lowest median incomes.

American Indian and Alaska Native families had the lowest median income of \$56,700 — less than half of the state's median income.

Asian and Pacific Islanders had the highest median income of \$151,000.² Racial disparities in household income and in child poverty are tied, in part, to historic and ongoing policies and practices that have affected the economic opportunities available to Black or African American, Hispanic, Native American, and many other non-white families in Colorado.³



The Cost of Living Is Going Up.

Colorado is becoming more expensive. Every two years, Colorado Legislative Council staff conduct a School District Cost of Living study to support the school funding formula in allocating dollars across school districts. While an imperfect measure for the cost of basic needs, these data can begin to describe changes in costs for families over time. Between 2021 and 2023, the cost of living increased by 6.77% or more in 57 of the 178 school districts in Colorado. Six of these districts' cost of living increased by over 10% in just two years.⁴

The U.S. Bureau of Labor and Statistics also calculates change in costs through the Consumer Price Index for All Urban Consumers (CPI-U), reported at the national, regional, and local-urban levels. In the Denver-Aurora-Lakewood area between November 2023 and 2024, the price of goods rose by an average of 2%. The cost of food rose by 3.6%, mainly because the cost of food outside of the home rose by 5.6%. The cost of energy decreased by 8.1%.⁵

CHILDREN LIVING IN POVERTY

The federal poverty level (FPL) is calculated by tripling the annual cost of food in 1963 and adjusting for inflation and family size. Children in families with incomes at or below the FPL — \$30,000 per year or less for a family of four in 2023 — are said to be living in poverty.






Childhood poverty rates varied widely across Colorado communities.

The share of children living in poverty has remained mostly stable in recent years. In 2023, an estimated 10.9% of Colorado children lived in poverty. Colorado had a lower rate of childhood poverty than the nation as a whole (16.0%). However, there were still roughly 130,000 children experiencing poverty.⁶

Children living in rural counties were more likely to be living in poverty. The highest childhood poverty rates were found in Costilla (37.2%) and Crowley (31.8%) counties and the lowest rates were found primarily along the Front Range and mountain resort regions.⁶

As in previous years, children of color were more likely to be living in poverty. In 2023, Hispanic children and children of two or more races were more than twice as likely to be living in poverty than white children. The margin of error was too large to report data on children who were Black/African American or American Indian/Alaska Native.⁷

Children Living in Extreme Poverty in Colorado

Between 2019 and 2023, roughly 65,000 children under 18 (5.4%) were living in families whose income was less than half of the federal poverty level — \$15,000 a year or less for a family of four in 2023. The rate of extreme childhood poverty has remained the same for the past five years.⁸



BEYOND THE FEDERAL POVERTY LEVEL

The federal poverty level does not necessarily reflect the amount of money a family needs to meet basic needs. Even a family making double the federal poverty level (200% FPL) may still not have enough to make ends meet. This is why many government programs, including public health insurance, child care, and free and reduced-price lunch, serve children from families with incomes above the federal poverty level. A broader look at family income helps us better understand the true number of families that lack financial security.

Between 2019 and 2023, roughly 30% of Colorado children lived in households with incomes below 200% of the federal poverty level.



While Colorado has a relatively small share of families with incomes below the federal poverty level, a significant share of children still live in households with low incomes. Between 2019 and 2023, 28% of children were in households with incomes below 200% of the federal poverty level and 44% of children were in households with incomes below 300% of the federal poverty level.⁸ Many rural counties had more children living in households with incomes below 200% FPL. The average family income was higher among children in Boulder, some Denver metro area counties, and in the mountain regions.⁸

INCOME SUPPORT


In 2024, the Prenatal-to-3 Policy Impact Center named Colorado the top state in the nation for resources that support for families with young children. **Between 2020 and 2024, Colorado increased the total resources available to a parent earning minimum wage by \$21,627**, largely through more state investments in paid family medical leave [see page 45] and tax credits.⁹

Tax Credits

Colorado families can use multiple state and federal tax credits to increase their household income. The Earned Income Tax Credit (EITC) exists at the federal and state levels and provides a refundable tax credit for low-to-moderate income working families. The federal Child Tax Credit (CTC) also provides a partially refundable tax credit for eligible families with children and the state Child Tax Credit provides a partially refundable credit for eligible families with children under 6. Combined, parents can receive up to \$3,200 through state and federal Child Tax Credits. Additionally, the Family Affordability Tax Credit (FATC) is a new refundable state tax credit available to eligible families with children in tax year 2024. Parents can receive up to \$3,200 if they have children under 6 and up to \$2,400 if they have children between 6 and 16 years old.

Basic Cash Assistance

Families with very low incomes may be eligible for basic cash assistance through the Temporary Assistance for Needy Families (TANF) program, known here as Colorado Works. Basic cash assistance provides modest monthly payments to families with children living far below the poverty level. A family of three, for example, must make less than \$421 each month or \$5,052 a year to qualify. In 2023, **47,003 children, or 3.8% of all children in Colorado, received TANF basic cash assistance.**¹⁰ As of May 2025, a family with one adult and two children receives \$592 per month in TANF basic cash assistance.

COST OF LIVING: ALICE HOUSEHOLD SURVIVAL BUDGET

Each household has its own unique budget needs depending on its size, location, and family situation. The United Ways of Colorado launched the Asset Limited, Income Constrained, Employed (ALICE) project in January 2025 to more specifically estimate the financial needs of Colorado families.



The Data

The United Ways of Colorado calculates a Household Survival Budget — the minimum income necessary to meet basic needs — based on household size and location. The ALICE Project measures both the cost of living and the number of households that may lack economic security in each county and across the state.

The average Colorado family of four needed \$93,000 a year to make ends meet in 2023.



HOUSEHOLDS WITH CHILDREN EXPERIENCING FINANCIAL HARSHIP, 2023




HOUSEHOLDS WITH CHILDREN EXPERIENCING FINANCIAL HARSHIP, 2023

In 2023, the average Colorado household with two children needed \$93,048 to meet its basic needs. Budgets varied across the state, ranging from more than \$125,000 in Summit County to \$67,000 in Bent County.¹¹

An estimated 28% of Colorado households with children made less than their county Household Survival Budget. Kids living with one parent were most likely to lack financial stability: Nearly 50% of single parent, male-led households and 70% of single parent, female-led households did not make enough money to afford their basic needs. In comparison, only 16% of married households with children were unable to afford their basic needs.¹¹

2025 SPOTLIGHT: HOUSING & HOMELESSNESS

Stable, safe housing is critical for children's short- and long-term physical and mental well-being. Children without stable housing are more likely to have poor overall health, adverse childhood experiences, and struggle to meet academic standards.¹² In Colorado, the share of children experiencing housing instability is increasing.



The Data


Data on housing and homelessness are provided by the U.S. Department of Housing and Urban Development; the Colorado Department of Education; the National Low Income Housing Coalition; and the Colorado Judicial Branch.

HOMELESSNESS

Many young Colorado families do not have stable housing. **An estimated 10.3% of people who gave birth in the 2023 calendar year did not have a steady place to live or were concerned about losing their housing in the few months after giving birth**, according to the Colorado Department of Public Health & Environment's Baby & You Survey.¹³

Each year, the U.S. Department of Housing and Urban Development requires localities to conduct a Point-in-Time count of all people experiencing sheltered and unsheltered homelessness. In 2024, Colorado's Point-in-Time count reported 4,781 children experiencing homelessness, more than double the 2,291 children counted in the prior year.¹⁴ According to the Colorado Coalition for Homelessness, the exact cause of this increase is unknown. But it may reflect an increase of immigrant families arriving in Denver, high housing costs, and difficulty affording rent amid inflation.¹⁵


STUDENTS EXPERIENCING HOMELESSNESS SERVED BY THE MCKINNEY-VENTO PROGRAM, 2018-24

The McKinney-Vento Homeless Education program, offered through the Colorado Department of Education, is a federally funded program that serves children experiencing homelessness to support stable school enrollment, education, and nighttime residence. Unlike the Point-in-Time count, the program includes all students who experienced homelessness throughout the entire year, not just on a single day, and uses a broader definition of homelessness to include children who have unstable housing but do not live in shelters.

In school year 2023-24, the McKinney Vento program served 22,896 Colorado children, roughly 2% of all public-school students. Most of these students were living in a ‘doubled-up’ arrangement, meaning they were sharing housing with others often due to loss of housing or economic hardship.¹⁶


EVICTIONS

The increasing number of children experiencing homelessness is, in part, due to challenges in affording housing. In 2024, the fair market rent for a two-bedroom apartment in Colorado was \$1,948 each month — a **\$3,324 increase in annual rent costs from the previous year**.¹⁷

Average annual rent for a two bedroom apartment in Colorado increased by about \$5,000 between 2022 and 2024.



Evictions are becoming more common.



The newly released Residential Eviction Filings dashboard describes all evictions across the state, including households both with and without children. Between 2021 and 2024, residential evictions more than doubled, from 21,757 in 2021 to 44,932 in 2024. **Roughly 40% of eviction filings in 2024 were due to nonpayment** — which may reflect families' struggle to afford rent.¹⁸

National research has found that households with children are twice as likely to be threatened with an eviction as adults without children.¹⁹ While Colorado's data cannot currently differentiate between households with and without children, increased evictions across all households likely points to growing housing instability for kids.

Health



In 2024, the Annie E. Casey Foundation ranked Colorado 28th in the nation in **children's health** based on four measures: low birthweight, lack of health insurance, child deaths, and childhood obesity. While we know that children's health extends beyond only these data, Colorado's low ranking points to a need to better understand and support child health and well-being.

Highlights

More children were insured by Child Health Plan Plus (CHP+) in fiscal year 2023-24. Enrollment in CHP+ grew by roughly 60,000 in fiscal year 2023-24. Many of these children were likely previously enrolled in Medicaid but now qualify for CHP+ because their families' incomes increased.

Fewer pregnant people received early prenatal care in 2023 than in the prior decade. In 2023, 22% of babies were born to parents who did not receive prenatal care in their first trimester.

Between 2016 and 2023, fewer teens died by suicide but more died by accidental overdoses, motor vehicle accidents, and homicide. The rate of children ages 15 to 19 who died as a result of suicide decreased to 14.6 death per every 100,000 teens in 2023, down from 18.1 deaths in 2016. However, rates of accidental overdoses, motor vehicle accidents, and homicides were significantly higher than they were in 2016.

PREGNANT & INFANT HEALTH

Prenatal care and a healthy birthweight are linked to a child's short- and long-term health. Colorado tracks data on its youngest children to understand how well we are supporting expectant parents and babies.



The Data

The Colorado Department of Public Health & Environment reports data on prenatal care, infant health, and infant mortality for all babies born in Colorado within a given year.

PREGNATAL CARE

High-quality prenatal care helps prevent complications and supports good health for both the parent and baby.¹ But some Colorado parents do not receive prenatal care in their first trimester, known as early prenatal care.

The share of babies born to parents who received early prenatal care dropped to its lowest point in a decade.

Most prenatal care costs are completely covered under public and private insurance plans in Colorado. Despite this, the use of early prenatal care in 2023 was the lowest in a decade.

Twenty-two percent of pregnant people who gave birth in 2023 did not receive prenatal care in the first trimester — a four percentage point change from the prior year.²

The share of expectant parents who received prenatal care varied widely across counties, with the lowest rates in the southeast corner of the state. These low rates may in part be due to lack of access to providers.³



LOW BIRTHWEIGHT


A baby born weighing less than 5.5 pounds is considered to have a low birthweight. These children are at a higher risk of serious medical complications at birth, long-term chronic health conditions, and dying before their first birthday.⁴

Colorado has one of the highest rates of low birthweight in the country.

One in ten babies were born weighing less than 5.5 pounds at birth.




BABIES BORN WEIGHING LESS THAN 5.5 POUNDS BY COUNTY, 2023

In 2024, Colorado was among the top 10 states with the highest rate of babies born underweight. About 10% of babies were born with a low birthweight in 2023.^{5,6} The frequency of low-weight births varied by race and ethnicity. Black or African American children were six percentage points more likely to be born underweight than the rest of the population.


Low birthweights are often due to early deliveries or a restriction on a baby's growth while they are in the womb which can be caused by a variety of factors like smoking, poor nutrition, stress, infections and violence.⁷ The high rate of low birthweight in Colorado may also be due in part to the state's relatively high altitude.⁸

INFANT MORTALITY

The infant mortality rate describes the number of babies who died before their first birthday per every 1,000 births. The most common causes of infant mortality include birth defects, prematurity and low birthweight, and sudden infant death syndrome.⁹

Infant mortality varied widely across races and ethnicities.

Colorado's infant mortality rate has remained relatively stable over the past few years. In 2023, there were roughly 270 babies who died before their first birthday, or 4.5 deaths for every 1,000 births. Mortality rates were much higher among babies who were Hispanic or Black.¹⁰ Infant mortality is linked to a variety of factors including poverty, a parent's well-being, public health, and the availability of proper health care.¹¹

IMMUNIZATIONS


Vaccinations strengthen children's immune systems and protect against disease.¹² Colorado requires immunizations for common diseases such as Hepatitis B, chickenpox, measles, and rubella for all children attending school or licensed child care. However, Colorado is one of only 13 states that allows personal, religious, and medical exemptions from vaccine requirements.¹³



The Data


The Colorado Department of Public Health & Environment collects data on children who are fully immunized or exempt from vaccinations from all child care providers, public schools, and colleges and universities.

Fewer Kindergartners were fully immunized in 2023-24.

In school year 2023-24, about 90% of Kindergartners were in compliance with their vaccination requirements, meaning they were either fully immunized or exempt from vaccinations. Despite a slight increase between school years 2022-23 and 2023-24, a smaller share of Kindergartners received all their vaccinations than in the 2019-20 school year.¹⁴

About 92% of K-12 students were fully immunized or exempt from vaccinations. Rates ranged across communities. Nine school districts had fewer than 80% of students in compliance with their vaccinations.¹⁴ These communities are at a higher risk for outbreaks of diseases such as measles, mumps and rubella, which require a 95% vaccination rate to keep the community safe from disease.¹⁵



FOOD INSECURITY

Children need enough to eat to grow and learn. Kids without enough food are more likely to have overall poor health, higher rates of emergency room visits, and worse mental health.¹⁶

The Data

The U.S. Census Bureau surveys families on their level of food security every few years. The Baby & You Survey, conducted by the Colorado Department of Public Health & Environment, captures information about Colorado parents who recently gave birth about their family experiences, including food insecurity.

Many Colorado children face food insecurity.


Many Colorado families reported concerns about having enough food to eat. Between 2021 and 2023, 11% of children were in families that faced food insecurity at some point in the year.¹⁷

Families with newborn babies were even more likely to report food insecurity: Nearly one in three (31%) parents who had recently given birth were worried about running out of food before there was enough money to restock within the last year.¹⁸

One in four children were overweight or obese

Access to nutritious food is essential to help children keep a healthy weight. Kids who are overweight are at increased risk for chronic health conditions, poor mental health, and a lower self-reported quality of life.¹⁹ While Colorado has one of the lowest rates of childhood obesity in the country, there are still a significant number of kids above a healthy weight in our state.

In 2022-23, one in four Colorado children were overweight or obese.²⁰



Colorado's Healthy School Meals for All program provides free food to public school students, helping ensure children have enough to eat. For more information, see page 63.



The **Supplemental Nutrition Assistance Program (SNAP)** is a federally funded program that helps families get food by providing monthly cash for groceries and other food expenses. In 2024, 317,040 Colorado children participated in SNAP — an increase of 33,627 children from 2021.²¹

ORAL HEALTH

Healthy teeth and gums help children eat, speak, and smile. Good oral hygiene and a proper diet can prevent cavities and tooth decay and support kids' overall health and well-being.²²

The Data

The Colorado Health Access Survey estimates the number of children who have access to dental hygiene services. The Colorado Department of Public Health & Environment conducts the Basic Screening Survey, which randomly screens public school students in Kindergarten and third grade for both treated and untreated dental decay.

Most kids had access to dental hygiene services, but tooth decay is becoming more common.



Nearly 90% of Colorado's kids had access to dental hygiene services when they needed it.²³ However, the most recent survey of public school students revealed that children's oral health status is getting worse. **The presence of tooth decay increased by 15 percentage points among Kindergartners and 14 percentage points among third graders between the 2016-2017 and 2022-23 school years.** While the presence of tooth decay increased across all communities, it was most common in low-income communities.²⁴


CHILD DEATHS

While most Colorado children live to be adults, children die every year from preventable deaths. Knowing the common causes can help us to better protect and support our kids.

The Data

The Colorado Department of Public Health & Environment reports data on child deaths and causes of death through its Vital Statistics Program.


The rate of deaths is significantly higher among teens than among younger children.





Teens were less likely to die by suicide, but more likely to die as a result of accidental drug overdose, motor vehicle accident, or homicide.

The number of deaths among Coloradans ages 1 to 19 remained relatively stable between 2020 and 2023, around 400 deaths each years. However, between 2013 and 2023, the rate of deaths among teens ages 15-19 increased by about 17 deaths per 100,000 teenagers.²⁵

In 2023, the most common causes of unintentional injury deaths among all children were motor vehicle accidents, unspecified accidents, and accidental drug overdoses. But the causes of death among teens have been changing. The rate of teen suicide is lower than it was in 2016. Meanwhile, the rate of deaths due to accidental overdose, homicide, and motor vehicle accidents increased.²⁵ These data point to a need to better understand the underlying causes and provide greater support to teenagers.


UNINSURED CHILDREN

Children with health insurance are more likely to visit a doctor for primary and preventive care, ultimately improving their long-term health and reducing costs for families, providers, and the health system.²⁶

The Data




CHILDREN UNDER 19 WITHOUT HEALTH INSURANCE, 2022





More Colorado children had health coverage in 2023: Just 4% of Colorado children were uninsured, down from 9% in 2013.²⁷ However, rates varied across communities. American Indian or Alaska Native children were least likely to have insurance, with an uninsured rate of 7%. The highest rate of uninsurance was among children whose families made between 150% and 199% FPL, despite the fact that these families qualify for public health insurance coverage.²⁷

Well-Child Visits and Pediatric Care

Well-child visits are important, routine check-ups during which a child's pediatrician monitors and supports their health, growth, and development. The American Academy of Pediatrics recommends 11 well-child visits between the ages of 0 and 30 months and annual visits starting at 3 years old.²⁷ Currently, there are not publicly available data on children in Colorado who attend the recommended number of well-child visits. This information would help us understand the state of children's health and health care access.

Colorado needs pediatricians to ensure all kids have access to well-child visits and support their overall health. In 2024, the American Board of Pediatrics ranked Colorado 15th for the ratio of general pediatricians available to number of children needing care: Colorado had 1,073 pediatricians, or one pediatrician for every 1,132 children. This was slightly better than the national rate of one pediatrician for every 1,511 children.²⁹

2025 SPOTLIGHT: PUBLIC HEALTH INSURANCE

Families that do not receive health insurance through an employer and do not make enough money to afford private insurance can enroll in public health insurance to help them access and afford important services. In state fiscal year 2023-24, more than one in three Colorado children (38%) were enrolled in public health insurance through Medicaid or Child Health Plan Plus (CHP+).³⁰

The Data

The Colorado Department of Health Care Policy & Financing reports data on all public health insurance programs, including Medicaid and Child Health Plan Plus (CHP+). Enrollment data from the 2024-25 fiscal year, the first full year without any pandemic-era continuous enrollment policies in Medicaid and CHP+ since 2020, are not yet available.

Medicaid and CHP+ provide health coverage for children in households making less than 260% FPL.

During the COVID-19 public health emergency, the federal government required that Medicaid and CHP+ allow children to remain insured without having to annually confirm their eligibility. Between the spring of 2023 and 2024, the programs returned to pre-pandemic policies and again began requiring families to reapply each year, a change referred to as the Medicaid unwind.


Many children lost Medicaid coverage during the transition, at least temporarily, due to loss of eligibility or administrative errors. However, **new data suggest that even when there were initial gaps in coverage, most children were ultimately re-enrolled in Medicaid or CHP+ by the end of fiscal year 2023-24.**

In fiscal year 2023-24, Medicaid and CHP+ served a combined total of 686,259 children — nearly 2,000 more children than the previous year. However, the number of children in each program changed significantly. Between fiscal year 2023-24 and the prior year, Medicaid enrollment decreased by 57,557 and CHP+ enrollment increased by 59,542.³¹

As families were required to again report income after the pandemic, many children who were enrolled in Medicaid had household earnings that made them ineligible for Medicaid and instead eligible for CHP+. However, the public health insurance policy landscape continues to evolve. Data from fiscal year 2024-25, the first year completely unaffected by pandemic-era policies, will offer a clearer picture of the impact of the Medicaid unwind and other changes to the public health coverage policy landscape.

EXPANDING PUBLIC INSURANCE COVERAGE

Cover All Coloradans: Coverage for Undocumented Kids and Pregnant Adults

On January 1, 2025, undocumented children and pregnant and postpartum adults became eligible for health coverage through Medicaid and CHP+ for the first time because of Cover All Coloradans (HB22-1289). Colorado is one of 14 states to provide comprehensive state-funded health care coverage for children, regardless of immigration status. In the first few months, more than 14,000 Coloradans gained coverage through this expansion, including more than 11,000 children.³² Many previously went without access to comprehensive perinatal care or well-child visits.

Continuous Eligibility Ages 0-3: Keeping Kids Covered

At the end of 2024, the Centers for Medicare and Medicaid Services (CMS) approved Colorado's Section 1115 Waiver to implement multi-year continuous eligibility for kids ages 0 to 3, meaning low-income children who qualify for Medicaid or CHP+ in Colorado do not need to reapply or redetermine their eligibility during those 36 months. Colorado is one of 12 states implementing multi-year continuous eligibility to protect children from losing health coverage if their family's income changes. This policy reduces the administrative burden of processing applications for the youngest Coloradans and aims to reduce overall Medicaid costs as the children who stay enrolled will have access to preventive and primary care services that keep them healthier throughout their lifetime.

Early Childhood



The first years of a child's life set the stage for their long-term development and success. Colorado has a growing system of early childhood service and learning opportunities for its youngest children and families.

In 2023, Colorado was home to 379,117 children ages 0 to 5.

Highlights

More than two-thirds of Colorado 4 year olds participated in the Universal Preschool Program. In its first year, the Universal Preschool Program provided free, part-time preschool to more than 40,000 children, or roughly 70% of Colorado 4 year olds.

Colorado's child care capacity is growing. Between September 2023 and September 2024, the state added roughly 4,000 slots for children under 6 and 6,000 slots for school-age children.

More children are getting evaluated and supported for developmental delays. Between 2021 and 2023, Colorado nearly doubled the number of young kids who were evaluated for developmental delays. Increased evaluations also led to more kids getting the services they needed.

TYPES OF CHILD CARE

Young children need full-time care from a trusted adult. Many families choose to use licensed child care providers or rely on a nanny or a family, friend, or neighbor for care. In others, a parent stays home with their children. Reliable child care is particularly important for working parents. In 2023, roughly 40,000 Colorado parents reported quitting a job, not taking a job, or greatly changing their job because of problems with child care.¹

FAMILY CHOICES

Each family has its own unique child care needs and preferences. New data on Colorado family choices helps us better understand how our child care systems are meeting — or not meeting — family needs.

The Data

The Health eMoms Survey Program, conducted by the Colorado Department of Public Health & Environment, provides the best available data on families' child care decisions. Coloradans who gave birth between 2018 and 2020 were surveyed when their child was 1 year old and again when their child was 3. The survey was conducted during the COVID-19 pandemic, between 2018 and 2021, which may have affected families' work and child care arrangements.



Most young children were cared for by a family member, but more children attended formal child care as they got older.



Most infants and toddlers were cared for by a parent or relative. In their first year, an estimated 73% of infants were cared for by a family member. Fifty-four percent were with their parents full-time and 19% were with a relative. As those children grew to age 3, 65% were still spending a majority of their time with their family. However, some families transitioned to child care centers. Parents were twice as likely to use licensed child care when their child was 3 years old compared to when they were 1.²

Most families were happy with their child care, but some would have preferred access to a child care center instead. Roughly one in five families wanted a different type of child care. Among these families, 70% would have preferred a child care center or preschool. One of the biggest barriers to these centers was the high cost of care.²

While parents' decisions reflected in the Health eMoms Survey were likely influenced by the COVID-19 pandemic, more recent national data also indicate that many children are still cared for by their family: About one in five parents across the country relied on a relative for child care.³

Parental Leave

Over this past year, Colorado introduced a new support for parents to stay home with their child, at least in their earliest days. In 2020, Colorado voters established the Family Medical Leave and Insurance Program (FAMLI), which gives Coloradans 12 weeks of paid family leave, including paid parental leave for each parent after a child is born. The program took effect in January 2024. As of January 2025, **63,910 parents** had applied to use FAMLI support for parental bonding leave.⁴

LICENSED CHILD CARE CAPACITY

Many families use a licensed child care provider such as a child care center or home as a safe place for their children to learn and grow. These providers are an essential part of our child care system, offering part- and full-time care to many of Colorado's kids.




The Data

The Colorado Department of Early Childhood reports child care providers' licensed capacity to the Colorado Information Marketplace. Licensed capacity reflects the maximum number of kids each provider can serve. However, some providers serve fewer children than they report, whether by choice, such as a decision to maintain smaller staff-to-child ratios, or because they cannot find enough teachers. These data are compared to the U.S. Census Bureau American Community Survey, which estimates the number of children younger than 5 with all parents working.

Licensed child care capacity in Colorado is increasing.

In September 2024, Colorado had 248,371 child care slots available to children ages birth through school-age (6-12) and 164,977 slots available to exclusively children ages birth to 5. This was an increase of about 10,000 slots, including 4,000 new slots for children under 6 and 6,000 new slots for school-age children.⁵

There were only enough child care slots to serve roughly two of every three young children in families with all parents working.

Despite this growth, there was only enough licensed child care capacity to serve two-thirds of children under age 6 in families where all parents were working. In September 2023, providers reported 164,977 slots compared to an estimated 246,991 children under the age of 6.^{5,6}

While not all families are looking for licensed child care, differences in the number of slots available and the number of children who need care point to a potential need to support providers in adding more slots or families in finding alternative approaches to care.

Supporting the Child Care Workforce

A strong and sustainable workforce is essential for making sure Colorado's families have safe and reliable child care. One of the biggest reasons providers cannot expand their capacity is due to trouble with recruiting and retaining child care workers.⁷ Recently, Colorado has made progress in paying its teachers higher wages: In May 2023, Colorado ranked 5th in the nation for highest average salary for child care workers.⁸ However, wages still remained low relative to other Colorado industries. In 2023 the annual mean wage among child care workers was \$38,240, or \$18.39/hour — almost 50% less than the average hourly wage for all Colorado workers.⁹ Many child care workers do not have enough money to make ends meet. An estimated 13% of the Colorado child care workforce were living in poverty and 32% relied on the public safety net in 2022.¹⁰

THE COST OF LICENSED CHILD CARE

Licensed child care is expensive. The federal government recommends families spend no more than 7% of their income on child care, but most families in Colorado spend far more.^{11, 12} This high cost is a burden on family budgets and prevents some parents from using licensed child care altogether. In a recent national study, the most common reason child care providers reported having empty slots was because they believed parents could not afford to enroll their children.¹³



The Data

The cost of child care varies by location, type of child care, and a child's age. Child Care Aware of America partners with state and local departments to estimate the average cost of child care across Colorado. For county-specific prices, the National Database of Childcare Prices uses the Colorado 2022 Market Rate Survey.

Colorado is one of the most expensive states for child care.



Child care in Colorado is particularly expensive. In 2023, Colorado was ranked as the fourth least affordable state for center infant care by Child Care Aware of America: Families had to pay almost \$20,000 a year for full-time care for a young baby.¹² A family of four making less than \$81,000 — or 270% FPL — would have needed to pay 24% of its earnings to afford care for an infant in a center and 44% of its earnings to afford care for an infant and a toddler.

Some Colorado counties had more affordable care than others. For example, in 2024 the annual cost of infant care at a center ranged from \$5,989 in the most affordable counties to \$24,794 in the most expensive.¹⁴ However, some of the counties where cost is more affordable also have lower median incomes and higher rates of poverty.



REDUCING COSTS FOR FAMILIES WITH LOW INCOMES

Programs supported by federal funding help make child care more affordable for low-income families.

Colorado Child Care Assistance Program

The Colorado Child Care Assistance Program (CCCAP) subsidizes the cost of child care for low-income families with funds from the federal Child Care and Development Fund. Families can enroll in CCCAP if they are working or in school and make less than 85% of the state median income — roughly \$110,580 for a family of four in 2024. **In fiscal year 2023-24, CCCAP served 25,864 children, or 9% of all eligible children.**¹⁵

In 2024, the federal government passed a new rule that required states to limit out-of-pocket costs for families and increase payments to child care providers.¹¹ While the rule will improve CCCAP's support for families, without additional funding, Colorado cannot afford the higher costs and may be forced to reduce the number of kids it serves. Colorado families are already feeling the impact of this change. In anticipation of these increasing costs, many counties have stopped enrolling new children to make sure they can afford continued support for the children they already serve.

Head Start & Early Head Start

Early Head Start, serving children ages 0 to 2, and Head Start, serving children ages 3 to 5, provide comprehensive early care for children and education services for children and their families. Families can enroll if they are earning at or below 100% FPL — roughly \$30,000 for a family of four in 2023 and \$32,000 for a family of four in 2025. Families receiving other public assistance, experiencing homelessness, and children in foster care may also be eligible.

Over the past year, Colorado expanded the number of children it served as a result of more funding and new efforts to recruitment and enroll eligible families. In fiscal year 2023-24, Early Head Start served **3,778 infants and toddlers** and Head Start served **7,395 preschoolers**.

Combined, these programs served 15% more children than the previous year.¹⁵

2025 SPOTLIGHT: UNIVERSAL PRESCHOOL PROGRAM


In 2023, the Colorado Department of Early Childhood launched the Colorado Universal Preschool Program, which provides free part-time preschool to all 4 year olds in Colorado and qualifying 3 year olds. In its first year, the Universal Preschool program served nearly 70% of Colorado's 4 year olds. With more data and time, we will gain a clearer picture of how the program has changed Colorado children's access to preschool.

The Data

The Colorado Department of Early Childhood reports data on all 4 year olds who were served by the Universal Preschool program in its first year, fiscal year 2023-24. Data about 3 year olds served is forthcoming.


In fiscal year 2023-24, the Universal Preschool Program served 43,479 4-year-olds, nearly 70% of all children.

FOUR YEAR OLDS ENROLLED IN UNIVERSAL PRESCHOOL BY HOURS SUBSIDIZED, FY 2023-24



FOUR YEAR OLDS ENROLLED IN UNIVERSAL PRESCHOOL BY FAMILY INCOME, FY 2023-24




FOUR YEAR OLDS ENROLLED IN UNIVERSAL PRESCHOOL BY HOME COUNTY, FY 2023-24


FOUR YEAR OLDS ENROLLED IN UNIVERSAL PRESCHOOL BY RACE AND ETHNICITY, FY 2023-24

The Universal Preschool program provides 15 hours per week of free preschool to every 4 year old and 30 hours per week to children from families with low incomes who have an additional qualifying factor such as experiencing homelessness or learning English. Three year olds who meet the same qualifying factors may also be eligible for the program if there is sufficient funding. All 3 year olds receiving special education services are eligible as well. The program allows children to attend preschool at a community-based child care provider, a home-based provider, or a public school.

In its first year, fiscal year 2023-24, the Universal Preschool Program served **68.7% of Colorado's 4 year olds — 43,479 children**. Nearly 2,000 providers participated in the program. About half of children served were living in a household making below 270% FPL, about \$81,000 for a family of four. The Colorado Department of Early Childhood estimates that **participating families saved an average of \$6,100** on preschool.¹⁶

About 46% of participating providers were community-based, or private providers, while 36% were school district-based. A majority of students (56%) attended a school district-based program.¹⁶

EARLY INTERVENTION

Early Intervention Colorado screens and provides services to infants and toddlers with disabilities or developmental delays in areas like speech and walking. Identifying kids in need of support early and getting them the right services gives them a better chance to develop the skills they need to learn, grow, and succeed.¹⁷



The Data

The Colorado Department of Early Childhood collects data on the number of children who were evaluated by Early Intervention Colorado and enrolled in services.

Colorado nearly doubled the number of children who were evaluated for developmental delays between 2021 and 2023.

In recent years, Colorado expanded eligibility for developmental screenings and increased funding for early intervention services. This has grown both the number of children screened for developmental delays and enrolled in services. In 2023, Colorado evaluated 11,562 children for developmental delays, nearly double the number of children who were evaluated in 2021. This has also led to an increase of over 3,000 children enrolled in services who each received an individualized service plan.¹⁸ Getting more children evaluated and connected to services means more Colorado kids are getting what they need to build a foundation for learning, skills, and health.



Home Visiting

Home visiting programs are another opportunity for families to aid their child's development. These programs offer evidence-based, in-home services to families to support pregnant people and young children. Programs address a variety of needs including health, child development, school readiness, and the prevention of child abuse and neglect.

In fiscal year 2023-24, 11,807 children received home visiting services, roughly the same number of children served in the prior year.¹⁹ Children were served by one of the following models: Parents as Teachers (PAT), Home Instruction for Parents of Preschool Youngsters (HIPPY), Home-based Head Start, Nurse-Family Partnership (NFP), Child First, Family Connects, Baby Bear Hugs, Safecare, Healthy Steps, and Healthy Families America.

SCHOOL READINESS

Strong support for early childhood development helps young kids get ready for school.


School readiness data describe a child's preparedness to take part in and benefit from elementary school.

The Data

The Colorado Department of Education administers the Kindergarten School Readiness (KSR) assessment to all public Kindergartens in the fall of each year. The KSR is the best, most widely-used measure of children's knowledge and skills as they begin public Kindergarten. Kindergartners are assessed in six domains — physical well-being and motor development, social and emotional development, language and comprehension development, cognition, literacy, and mathematics.

Between half and two-thirds of Colorado Kindergartners demonstrated school readiness across six different domains.

In the fall of 2024, the share of Kindergartners ready for school ranged from 55% in mathematics to 67% in physical and motor development. In every domain, fewer children were considered ready for school than in the previous year. The drop was most likely due to an administrative change: The assessment increased the school readiness benchmark score in 2024, resulting in fewer children meeting expectations.²⁰

Public Education



Children's education helps them develop essential skills like reading, writing, and math that they'll use for the rest of their lives. Colorado has a diverse system of public schools — including online and in-person traditional and charter schools — that provide students with opportunities to learn and succeed.

Highlights

This year, Colorado is serving twice as many immigrant students as in the previous year.

In the 2024-25 school year, there were nearly 30,000 immigrant students attending Colorado public schools, compared with roughly 15,000 the prior year.

Youth report that their mental health is improving. Between 2021 and 2023, more middle and high school students felt better able to manage their stress and fewer had feelings of hopelessness.

More than half of students did not meet academic standards in English and math. In 2024, 56% of students did not meet expectations in English and 66% of students did not meet expectations in math. While there was some improvement from the prior year, scores remain lower than they were before the COVID-19 pandemic.

STUDENT BODY

Colorado has more than 1,900 public schools across 178 school districts that enroll students in pre-kindergarten through 12th grade.










COLORADO STUDENT BODY BY RACE AND ETHNICITY, 2024-25 SCHOOL YEAR

In the 2024-25 school year, Colorado's public school system served more than 880,000 students. However, enrollments continued to remain lower than they were in the 2019-20 school year October count. In just this last year, enrollment dropped by about 400 students.¹

At the same time, public schools are serving more immigrant students. Between the 2023-24 and 2024-25 school years, the immigrant student population nearly doubled from nearly 15,000 to 29,000 students. The English language learner population grew by a little less than 10,000 students to almost 124,000 students.¹

Changes in School Funding

In 2024, the Colorado legislature approved two significant changes to public school funding. The state eliminated the Budget Stabilization Factor, a Great Recession-era budgeting mechanism that resulted in the state investing almost \$10 billion less in public schools than it was constitutionally required to during the nearly-15 years it was in effect. The state also updated its school funding formula for the first time in 30 years. These shifts aimed to significantly increase funding for Colorado schools, especially schools serving students living in poverty, students who are learning English, and students with special learning needs.

2025 SPOTLIGHT: ACADEMIC ACHIEVEMENT

Standardized tests are an important tool for understanding children's academic performance and differences among groups of students, schools, and districts. In Colorado, fewer students are meeting expectations across grade levels and subject areas than before the COVID-19 pandemic. Students from homes with limited financial resources were consistently less likely to meet or exceed expectations. There are a variety of reasons for these declining test scores, including changes in the tests themselves and effects of the COVID-19 pandemic. The fact that a majority of Colorado students failed to meet academic standards in both English language arts and math points to a need for more support for students in and outside of the classroom.

The Data

The Colorado Department of Education measures students' academic performance through the Colorado Measures of Success (CMAS), the Preliminary SAT, and the SAT.






STUDENTS NOT MEETING EXPECTATIONS, GRADES 3 THROUGH 8:

Spanish Language Arts



In 2024, about two-thirds (66%) of students in grades 3 through 8 did not meet expectations in math and more than half (56%) did not meet expectations in English language arts. More than 80% of students did not meet expectations in Spanish language arts. There were small improvements in scores over the last year, but the share of students meeting academic standards still remains lower than in 2019.²

Three out of four (75%) 3rd graders who were eligible for free or reduced-price lunch did not meet expectations in English language arts. By comparison, fewer than half (44%) of their peers from higher income homes failed to meet expectations. These disparities persisted throughout elementary and middle school: Disparities in 8th grade were almost identical to disparities in 3rd grade.²

PSAT & SAT SCORES

Students in grades 9 and 10 take Preliminary SAT (PSAT) exams, scored out of 1520 points. Eleventh grade students take the national SAT exam, scored out of 1600 points. Students have the option to use their SAT score to display competencies and meet graduation requirements if they score 470 or greater in reading and writing and 480 or greater in math.




Average PSAT & SAT Scores, 2024

Economic disparities in test scores persisted through high school.



Colorado students' average scores on the PSAT and SAT were lower in 2024 than in 2023.³ This drop was expected: 2024 was the first time that the exams were administered online. The online exam is adaptive and more challenging, increasing the difficulty of questions if students answer correctly.

The average score for students eligible for free or reduced-price lunch was 150 points or more lower than the average score for students from homes with higher incomes.³ These gaps point to a need to support students by improving educational opportunities and access to targeted tutoring and enrichment activities.

SCHOOL EXPERIENCES

Students learn best and are more likely to be interested in class when they are in a safe and supportive environment. Colorado schools are using new tools to better understand and measure students' experiences in schools.

The Data

The Colorado Department of Education reports data on attendance, staff ratios, and other aspects of experiences at school. The Colorado Department of Public Health & Environment Healthy Kids Colorado Survey asks youth in Colorado about their well-being.



Data on School Climate Is Improving


In 2022, Colorado began requiring school districts to report data on a wider set of factors that contribute to school climate, including chronic absenteeism, student behavior, service provider ratios, and the use of restraint and seclusion in schools. The first of these reports was released in September 2024, but the data it included were lacking specificity on behavior incidents and disciplinary practices due in part to reporting inconsistencies across districts. In future years, with a fuller set of data on school climate, we will be better equipped to understand and improve student experiences across Colorado schools.

ATTENDANCE


Students' academic success is tied to their school attendance. A student's attendance in 9th grade is a better predictor of whether they will complete high school than their test scores.⁴ In Colorado, students are considered chronically absent if they miss 10% or more of school days in a school year, excused or unexcused.

Chronic absenteeism decreased after its pandemic peak.

In the 2023-24 school year, roughly 28% of students were chronically absent. While this is a decrease from prior years, the share of students who missed school regularly was still higher than before the COVID-19 pandemic.⁵ Rates of chronic absenteeism ranged widely across school districts.

Healthy School Meals for All

The Healthy School Meals for All program, enacted by Colorado voters in 2022, provides free meals to all students attending schools participating in the National School Lunch or School Breakfast program. The program aims to reduce the stigma of receiving free meals at school and the administrative burden of providing these meals. In the program's first year, school year 2023-2024, Healthy School Meals for All served almost 101 million meals and grew the number of students receiving free lunch by 32%.⁶



YOUTH MENTAL HEALTH

Since the COVID-19 pandemic, there has been a growing focus on youth mental health. The Colorado Department of Public Health & Environment administers the Healthy Kids Colorado Survey in schools and communities to better understand the health and well-being of kids in our state.

More youth are reporting better mental health and less stress.



Between 2021 and 2023, more high schoolers reported feeling able to manage their stress and fewer high schoolers reported feeling consistently sad and hopeless or considering suicide. There was a similar trend among middle schoolers.⁷ This improvement was echoed in the falling rate of teen suicide [see page 37].

Free Mental Health Services for Youth

Between October 2021 and April 2024, the I Matter Program reached:



In 2021, Colorado created the I Matter program to expand access to mental health and substance use disorder services for kids. I Matter provides up to six free therapy sessions and access to care navigators for all youth to help them and their families continue care beyond the covered sessions. Between October 2021 and April 2024, I Matter provided 12,486 youth with 49,521 free therapy sessions, 64% of which were made accessible through telehealth.⁸

TEACHERS

Teachers play a key role in a student's experiences and ability to learn. Providing livable wages and a supportive work environment are essential to hiring and keeping high-quality teachers in the classroom. The Colorado Department of Education reports on teacher turnover, teacher salaries, and teacher-to-student ratios.

More teachers are leaving the classroom. Between fall 2022 and fall 2023, Colorado's teacher turnover rate was 17%, up from 14% in the 2020-21 school year.⁹ This high turnover rate is leaving many positions unfilled: At the end of the 2023-24 school year, there were 635 teacher positions that remained unfilled, compared with 264 positions at the end of the 2018-19 school year.¹⁰ High workloads, increased interference in curricula, and low pay were the most common reasons teachers cited for leaving their jobs.¹¹ In 2024, Colorado ranked 46th in the nation for starting teacher salary and 24th in the nation for average teacher salary.¹²

GRADUATION RATES

Students who graduate on time are more likely to pursue higher education, have better health outcomes, and are less likely to participate in risky behaviors.¹³ In Colorado, graduation rates continue to rise, but vary widely across and within communities.

The Data

The Colorado Department of Education reports the rate of students who graduate on time – within four years of starting high school – by student cohort.


On-time graduation rates continued to rise this year.

More Colorado students graduated on time over the past decade. In 2024, 84.2% of students graduated in four years compared to 77.3% of students in 2014. However, some students are more likely to graduate on time than others. In the 2023-24 school year, foster care students were the least likely to graduate (40.4%), with graduation rates 44 percentage points lower than the state average. Students experiencing homelessness (61.6%) and migrant students (68.0%) were also far less likely to graduate on time than their peers.¹⁴


Graduation rates also varied by gender, race, and ethnicity. In the 2023-24 school year, graduation rates for Native Hawaiian or Pacific Islander students and American Indian or Alaska Native students were roughly 14 percentage points lower than the state average (69.5%). Female students had a higher graduation rate than male students: 86.6% of female students graduated on time, compared with 81.8% of male students.¹⁴
